

ICRPS 2015 Ireland - Review with James Breen

O: What was the summer school themes most relevant in the Irish about?

The ICRPS summer school is based weeks. on a trans-Atlantic comparison of rural policy issues and how rural policies are being implemented around the world. In the context of this summer school, rural Ireland was the topic. Themes such as environmental issues, regional development issues, rural tourism, access to rural services and other

Q: What was your most



memorable experience?

For those who were visiting Ireland for the first time, it was having that opportunity to give them their first experience of rural Ireland, and giving those who have to other aspects of rural Ireland getting a sense of what rural experiences are like. For example, learning about Connemara and the heritage and culture that can be seen there at the Burren and the Aran Irelands. These were the two most memorable parts of the summer school for me.

Q: How did it make a difference?

Certain initiatives in Ireland prompted a lot of interest from ICRPS participants. Examples: the Origin Green Initiative struck a lot of people - comparing different sustainability issues in countries. The Burren life project was another initiative that people could see the success of the project and the multi-disciplinary nature of it, which is what ICRPS is all about.

SAVE THE DATE! - ICRPS Alaska, July 14-26, 2016

Set your calendars to attend ICRPS Alaska, July 14-26, in 2016. The 13th annual event will offer a unique opportunity with a "northern perspective on global challenges." A variety of topics are to be covered include; the Food, Water and Energy Nexus, Health, Environmental Justice, Renewable Energy, and Climate Change.

Located in the heart of Alaska and only 200 miles from the Arctic Circle, the University and the city of Fairbanks offers modern amenities and wilderness access minutes outside of town. Excursions will expose participants to the amazing environment of Alaska's Interior, and also to the challenges of the rural North that result from misuses like climate change and energy development.

Helping to coordinate ICRRS 2016, Phil Loring, Assistant Professor at the School of Environment and Sustainability, University of Saskatchewan describes the overall theme of the conference as giving, "a northern perspective on all of those things that ICRPS does (comparative rural policy). Specific themes: Food energy, water policy, environmental justice, and indigenous issues will be talked about that haven't been as high profile as in earlier summer schools."

A highlight of ICRPS 2016 is that it will also overlap with the World Eskimo-Indian Olympics which will be an interesting thing for participants to witness. Mark your calendars and see you in 2016!
