Transformation of Resource Towns and Peripheries: Political Economy Perspectives

Transformation of Resource Towns and Peripheries incorporates case studies from Australia, Canada, Finland, and New Zealand to highlight internal and external economic restructuring processes in the post-war period, as well as similarities and differences in policy responses that are shaping change. This includes a discussion of the capital investment and restructuring strategies used by firms; the organization of the resource-based economy within a global context; changes in products, markets, and trading relationships; implications for labor force transition; and community responses to pursue new place-based economic development approaches.

The case studies speak to the challenges of reconsidering and repositioning rural policies and investments in a political environment where no renewed vision has been realized to better position resource-dependent regions to be competitive in the new global political economy.

As such, Transformation of Resource Towns and Peripheries is a useful guide for students and researchers of regional studies, geography, and rural and industrial sociology. This book will also have a strong appeal to policy-makers and local and regional development practitioners.
